1. All other terms & conditions to be considered as per incoterms & UCP latest edition unless otherwise agreed.
2. Please note 10% of total PI amount should be considered as performance guarantee which could be confiscated if buyer won't be able to do his commitment.
3. At any force major conditions like earth quick, flood & in any case beyond the sellers control which lead the production to be halted, buyer should be informed by the seller at once & the seller is absolved from his commitment during the force major time.
4. In case of non-consideration of condition or buyer non-confirming of this PI until validity time, supplier IS entitled to cancel the current sales.
5. At any case if payment of transportation of the cargo was not fulfilled for any reason from buyer side according to the above conditions, supplier is entitled to cancel this PI and confiscate any payment related to this PI
6. 10% advance payment must be paid within validity time otherwise PI will be cancelled.
7. Buyer must pick up all the goods during the time of delivery otherwise the delivery of the remaining goods will be subjected to new contract.
8. For each PI only one BL charge will be paid.
9. If this order be subjected to the UAE 5% VAT regulation buyer shall be committed to pay the tax and all related charges which would be added to the total amount of this PI.
